2. Status Reports

Starts: 808 for the season and an average of 47 starts per meet. There were also 313 starts for the Trail Run.

Membership: 281 members... see report for further details

Equipment/technology: Garage clean up completed. Inventory needs to be done as it may have not been done since 1996.

Maps/Mapping/Map hikes: An idea to compensate ROC members \$10-\$20/hour depending on skill level to map new areas was discussed (Genesee County Park and Alasa Farms are possibilities).

A formal proposal will be made at the first BOD meeting in 2017.

Marketing/Publicity/Outreach: Facebook 497 Likes (Trail Run spent \$50 to boost, reached 7,986 people, 198 engagements (looking at pictures)... Meetup 341 members, 114 past events since joining.

We need someone to replace Steve to send out press releases roughly 3 weeks before each event.

Schedule 2017: Should be ready to hand out at Winterfest in January 2017... We could do an event at Cummings Nature Center on 2/19/2017 and at Alasa Farm at their Fall Festival in October 2017.

A Meet 2017: Permits and insurance is all set, Workers' List was sent out for volunteers to confirm participation.

Volunteers: 57 different volunteers, many of them volunteering in the double digits... We used "Sign Up" for volunteers for the Trail Run suiting our needs, but it may not be a good fit for regular events throughout the year

Budget: no report

POC's: One post has been repaired, one more to do, the rest are good

Trail Run: 348 registered...313 starts...packet pickup at Medved seemed to go very well. They also donated thirty \$15 gift cards. We had \$5389 in profit. Thanks to Heidi, Dick and Anne!

Retail Map Sales: doing very well

Website: send any ideas and changes to Lindsay

Ski-O: Stina has had conversations with RXCSF for possible collaboration

Ribbons: 115 awarded this year

3. Active Discussion/Action Items

Kolva Junior Award - motion to award this to Jackie Alexander who has helped with the String-O, Laurie Hunt/Lindsay Worner, motioned approved. Will decide exact award in January (monetary, plaque, e-punch, compass...).
