**Membership report** (Mike): Membership count is 133, 195 members as compared to 161 last year at this time. Report attached.

### Reports

<u>Permanent /Semi-permanent Courses</u> (Tom, Laurie): No report from Tom Cornell. Laurie would like to have more semi-permanent courses next season. The goal is to have Purple Pen and course setting workshops in March so members can learn to create courses that can be used for training activities and semi-permanent courses. Laurie is still working on information labels for the permanent courses.

<u>Volunteers</u> (Sandra): Sandra was happy to report that 103 volunteers have contributed this season. Anyone with five or more points is indicated on the chart with a star and will receive a free 2013 schedule t-shirt.

<u>Club Equipment</u>, Technology (Laurie, Tyler): Nothing to report.

Mapping: Status, Version control, Sales (Dick, Tyler, Carol): Dick is working on updates on Durand (east side), Genesee Valley, and Powder Mills. Dick is looking for assistance with Cobb's Hill (especially to map vegetation in the Washington Grove area). Linda is working on Durand (west side). Brian offered to help with updating the mapping in Highland Park of "open with scattered trees" vs "open woods".

<u>Hotline</u> (Carol): Carol has records of twenty calls in the second half of the year. <u>Publicity/Social Media</u> (Steve, Laurie): Steve is continuing to add contacts to his list and sending announcements and press releases. There are 93 members of meetup to date. We are seeing new attendees coming from the meetup site.

<u>Training</u> (Rob S): Twelve activities were held this year, publicized on the meetup site. Suggested sending notices on roc info next year. Laurie hopes to expand activities to include less experienced orienteers next season and would like to have beginner training activities at CCE workshops in March.

Junior Team (Mike): No report. Mike emailed a list of winners of national Junior events.

<u>Trail Run</u> (Brian): 200 total participants. \$1500 total profit. Runner feedback positive. Larry and Marilyn Zygo have retired after 18 years. They have provided the club with a procedure manual. Brian is willing to be Race Director for 2013. Detailed report attached. (Sandra has a list of food items and equipment needed for the Aid Station and the food, etc. in East Lodge. Both Carol and Marilyn gave her this info which will be passed on to Brian.)

<u>"A" MEET UPDATE</u>: Rick Worner will send reminder that area (Letchworth East) is embargoed. Mark Dominie has been working with Rick, Rob H, Lindsay and Linda regarding updating the map. Mark will be giving Rick an estimate of costs. Volunteer positions are being filled.

<u>Ribbon report</u> (Don): Thanks to Don for taking over sending ribbons to winners of 1st-3rd place. Total award recipients: 123 plus several who turned down ribbons, 2/3rds given out and 1/3 mailed. Report attached.

Annual Report: Laurie summarized ROC's 2012 activities. The Rochester Map Adventure was the newest event along with 3 Trail Challenges. All of these will continue for the year 2013. Besides these events, ROC held 16 other local events (total 20) plus 12 training events. ROC also had several National youth and adult winners. There were 103 volunteers this year, many helping 5 times or more, thereby earning free 2013 schedule t-shirts. There were 1238 starts to date including the Trail Run. A special thanks was given to Tyler for bringing ROC up to speed technically, Training Course Setters, Sandra for getting Volunteers, Dick for taking care of the mapping for several parks and for the newsletter, and Mary Kolva for her delicious refreshments. Thanks also to MD Sandi and CS Jim for an outstanding evening.

**Club Series:** Rick Worner gave out medals for the winners of the Club Series, both Sprints and Regular Meets.

A motion was made by Lindsay, seconded by Rick W, to adjourn the meeting at 6pm. Approved.
